# **AUTHORIZATION FOR TOWN SUPERVISOR TO EXECUTE HORSESHOE ROAD USE AGREEMENT**

On motion of <u>Councilman Bickford</u> seconded by <u>Councilwoman Rychlicki</u> the following resolution was ADOPTED – Aye – Pangrazio, Clark, Rychlicki, Keenan, Bickford Nay-0 Absent-0

WHEREAS, on December 9, 2022, Horseshoe Solar Energy LLC ("HSS") was issued a Siting Permit for a Major Renewable Energy Facility (the "Permit") by the State of New York Office of Renewable Energy Siting ("ORES"), pursuant to Executive Law Section 94-c ("Section 94-c"), for a 180-megawatt solar energy facility to be located in the Towns of Caledonia and Rush (the "HSS Solar Project"); and

WHEREAS, Section 94-c and the Permit require that HSS enter into road use agreements for the regarding repair of local roads damaged by heavy equipment, construction or maintenance activities during construction and operation of the facility; and

WHEREAS, HSS has agreed to use the Town's standard Road Use and Repair Agreement, tailored to reflect the contemplated road impacts associated with the Project (the "Road Use Agreement" attached as Exhibit A); and

WHEREAS, the Road Use Agreement provides for the identification and use of Designated Haul Routes, HSS funded road improvements, if necessary, HSS funded Pre- and Post-Construction Surveys to assess road condition, requirements that HSS repair damage at its expense incurred as a result of the Project activities, and a process for review and approval by the Town Highway Superintendent of Designated Haul Routes, necessary road improvements, road surveys, road crossings, and necessary repairs; and

WHEREAS, the Road Use Agreement has been reviewed by legal counsel for the Town and is acceptable as to form; and

WHEREAS, the Board has had an opportunity to review the Road Use Agreement and understands its contents.

NOW THEREFORE BE IT RESOLVED, that the Board approves the Road Use Agreement; and IT IS FURTHER RESOLVED, that the Board authorizes the Town Supervisor to enter into the Road Use Agreement on behalf of the Town of Caledonia, and execute those documents necessary to memorialize such agreement.
