OPEN FORUM

JANET CAPPOTELLI – LIV CO SOLAR ECLIPSE

Village Trustee Janet Cappotelli handed out copies of the Livingston County Solar Eclipse grant packages to the Town Board. Trustee Cappotelli stated to the Board that the County has asked the businesses, town & village to only have an event on the Friday prior to the event. She would like to have a band, activities for kids, adults, etc. There will be a meeting on Tuesday, October 24th at 6:30pm that she invited the Town Board to attend. Councilwoman Rychlicki attended a meeting regarding the festival last month and cited concerns that the head of the Caledonia Fairgrounds couldn't answer any questions about the event and how unorganized it was. Supervisor Pangrazio is going to check with Economic Development about restrictions to just a Friday event.

SETH WILLMORE – HATCHERY SOLAR

Seth Willmore of Oriden Energy updated the Board that he attended the Planning Board meeting in September regarding the 20-megawatt proposed solar project at Estes/Puncher Development. He plans to attend the next Planning Board meeting at the end of the month. Supervisor Pangrazio asked for more copies of the plans for the project for each board member. Seth stated he has good neighbor agreements from several neighbors around the area, however, Supervisor Pangrazio stated that it does not change the setbacks set in the zoning.

DEPARTMENTS/COMMITTEES

ATTORNEY – DWIGHT KANYUCK

Attorney Dwight Kanyuck updated the Board that the Livingston County IDA authorized the PILOT agreement with Horseshoe Solar and the agreement has been finalized. In addition, the Host Agreement has been signed and we are waiting for a counter signature.

ZONING – CODE ENFORCEMENT OFFICER TOM PERKINS

Code Enforcement Officer Tom Perkins had no report for the Board.

PLANNING BOARD - COUNCILWOMAN RYCHLICKI

Councilwoman Rychlicki updated the Board on the following:

- ➤ The Planning Board was not in agreement with the setbacks proposed by Seth Willmore for Hatchery Solar's proposed project.
- Not all neighbors signed the good neighbor agreement, contrary to what Mr. Willmore stated tonight.
- Supervisor Pangrazio stated regardless of good neighbor agreements, it does not change setbacks from roads and cited concerns over the ability of the plows to be able to plow the roadsides without hitting fences. He also stated the project is far from being approved and the Town will take the proper time to review all the documentation and make sure it is done properly and in compliance with the new zoning code.

BUILDINGS/GROUNDS – SUPERVISOR PANGRAZIO

Supervisor Pangrazio had no report at this time.

HIGHWAY – HIGHWAY SUPERINTENDENT RON BEACH

Highway Superintendent Ron Beach updated the Board on the following:

- The new baseball field is done, and the grass is growing.
- > The bleachers that were donated look nice.
- > The crew is finishing roadside mowing.
- The new sign for the Town of Caledonia is up on Route 36.
- The crew has been cutting shoulders of roads as well as working with the County on Linwood Rd.
- > The Town received their CHIPS reimbursement, however, received news that the CHIPS money going forward can not be used on the same road for a minimum of 10-years, making it difficult for the Town to complete different road repairs.
- The trucks are being inspected and prepped for the snow season.
- > Snow fences are being installed.
