Payments may be made in person, in our drop box or by mail at the Town Office, 3109 Main Street, in the said Town of Caledonia, each day from 8:00 a.m. to 12:00 noon and from 1:00 p.m. to 4:00 p.m., on Mondays, Tuesdays, Wednesdays, and Thursdays, and Fridays 8:00 a.m. to 12:00 p.m. excepting Saturdays, Sundays and holidays, for the purpose of collecting taxes listed on the said roll. Checks may be made payable to Seth Graham, Tax Collector, 3109 Main Street, Caledonia, NY 14423. Payment also may be made online at [www.townofcaledoniany.org](http://www.townofcaledoniany.org) (fees apply).

TAKE FURTHER NOTICE, that taxes may be paid on or before January 31, 2024, without charge or interest. On all taxes received after such date, there shall be added interest of 1 per centum for February and 2 per centum for March plus a \$2.00 mailing fee for second notification.

TAKE FURTHER NOTICE, that pursuant to the provisions of law, the unpaid taxes of the Town of Caledonia will be returned to the County Treasurer of the County of Livingston on the 2<sup>nd</sup> day of April 2024.
